INSTRUCTIONS REGARDING FEE FOR THE SESSION 2020-21

- 1. Admission should not be given to any student until and unless he or she clears the dues of previous year.
- 2. Fee receipt is to be given always for any type of fee collected from the parents. Separate Fee Receipt should be used for Board Examination Fee. It must be deposited in Bank.
- 3. Fee once paid by the parents will not be refunded in any case.
- 4. The Class Teacher should be instructed that the names of only those students must be entered in Attendance Register who shows the Fee Receipt to them. Those who fail to show the Fee Receipt, their attendance must not be taken.
- 5. Fee of every month should be deposited by 20th of every month. After 20th no fee will be deposited.
- 6.5% rebate will be given in the Tuition Fee only, if the fee of the entire session is deposited at the time of admission.
- 7. Late Fee No late fee in the first month. Late Fee in second month Rs.50/-. After second month name will be struck off.
- 8. Re-admission With the grace of Principal if the candidate is readmitted in the third month Re-admission Fee + three months Fee will be charged.
- 9. Teacher and Employee ward concession: Only the son/ Daughters, including legally adopted children of the permanent employees of the school will get concession in tuition fee only and all other dues shall be recovered in pro-rata basis. Concession is granted 100% to first child, 50% to second child, 25% to third child and no concession for all other children onwards.
- 10. Fee concession for Brother/Sister: Where two or more children of the same parent are studying in the school, they will get concession in tuition fee only and all other dues shall be charged on pro-rata basis. No concession to the first child, 50% to second child, and 25% to third child and no concession for other children.
- 11. On sad demise of parent(s): Where two or more children of the same parent are studying in the same school, they will get concession in tuition fee only and all other dues shall be charged on pro-rata basis.100% concession to first child for one year only,50% to second child and 25% to third child and no concession for other children.
- 12.TC/Duplicate TC fee : Rs 100/- shall be charged as TC fee and Rs 200/- for duplicate T.C. Duplicate TC shall be issued only on producing an affidavit on the non-judicial stamp paper of Rs 10/- only by the parents.
